The Consignor \_\_\_\_\_ and Climb On Equipment agree as follows:

1. This Relationship Agreement includes all present and future consignment sales agreements between the consignor and Climb On. All consignors who wish to consign items for resale at Climb On, must agree to the following terms or remove their items from sale immediately.
2. If you wish to have confirmation upon drop-off whether your items are sellable or final pricing you must drop them when there is a consignment manager on shift.
3. Items may be dropped off by the consignor at our location at any time and will be assessed for saleability within 10 days of each sales agreement, each sales agreement is not considered final and items are not considered accepted until they have been reviewed by a consignment manager.
4. If any items are not sellable you will receive 1 courtesy email and phone call (within 10 days) and have an additional 10 days to pick your item(s) up. After 10 days from the email notification if you have not picked up your unsellable items they will be donated or disposed of.
5. Consignors are encouraged to suggest prices by writing them on their Consignment Sales Agreement Form, but the final decision will be at the discretion of the consignment manager.
6. Accepted items will remain on sale for at least 120 days. The Consignor is responsible for claiming all unsold items after a period of 120 days and Climb On assumes ownership of any items that remain unclaimed by the Consignor after this period and may dispose of the item(s) as they see fit. All items are left at the owner's risk. Valid government photo ID is required to pick up items.
7. Climb On retains the right to dispose of or donate any items at any time during the 120 day sales period that are found to be unfit to sell due to disrepair or poor condition regardless of their expiry date. For example if an item is found to be broken, stained or otherwise not in working condition, you will be notified and given 10 days to retrieve your item or they will be disposed of.
8. All items provided by Consignor will automatically decrease in price by 10% of original asking price every 21 days down to a maximum discount of 40% off the original asking price.

**For example, Starting price = \$100**

Days	21	42	63	84
Discount	10%	20%	30%	40%
Selling price	90\$	80\$	70\$	60\$

9. Climb On will pay the Consignor for sale of items according to the following percentages: Items Sale Price: \$0 to \$250 is 50%, \$251 to \$500 is 60%, \$501 to \$750 is 70%, \$751 to unlimited is 80%. Consignors who use their credit toward in-store purchases will receive an additional 25% discount applied to the amount of credit being spent. \*Example: An item sells for \$100, the Consignor may collect \$50 in cash, or receive (\$50 + 25%) \$62.50 toward in store purchases.
10. Climb On will deduct our commission fees from sales proceeds due to the Consignor and Climb On will pay the net amount to the Consignor, provided that at least five business days have elapsed since the item(s) were sold.
11. The Consignor is responsible for checking with Climb On to determine whether any items have been sold and is also responsible to attend at the Climb On premises to receive payment. If the Consignor fails to attend Climb On premises to receive payment before 2 years after the date of their most recent Sales Agreement Form, Climb On will be entitled to retain all proceeds from the sale of the item(s) and will not be required to pay any amount to the Consignor. Valid Government Photo ID is required to collect your money.
12. Climb On is not responsible for any costs, loss of items, or liabilities or claims for damages arising from the consignment of the Consignor's items with Climb On or from the sale of those items or the use of those items by the purchaser(s).
