Vendor fees are: \$70 for a commercial 10' x 10' space to sell hand-made and retail products; \$35 for a single table 8' x 6' space for non-profit or informational booths not selling product. Spaces are within the common area of the Miller Hill Mall and exact location is at the discretion of event & mall management.

Vendors should provide their own chairs, displays or additional tables. Limited electrical hook ups are available at no charge on a first come basis. Electrical must be requested at registration and cannot be added the day of the event.

Space sharing is allowed, however a MNST19 and hold harmless must be included for each organization/business in the space. The primary vendor should be on the registration form. Commercial space vendors may purchase an additional 8'x8' space at a reduced rate if needed.

We request that all vendors pertain to the horse/farm/pet or western style industries in some way to keep with the theme of our event. We welcome vendors with hand crafted wares that are of interest to these industries as well as commercial products that do not provide a conflict of interest with mall tenants. Third party vendors will only be accepted if there is space left after March 1.

Please send in your vendor fees at the time of registration or your space may not be held. All vendor registrations are due by March 25, 2025 to ensure space at the Horse Fair. Hours are 10am until 6pm on Saturday, April 5, 2025 and vendors are expected to be present during the hours of the Horse Fair. Vendor fees are non-refundable after April 2, 2025. All vendors are required to submit a Hold Harmless Agreement and/or Certificate of Insurance for liability and a MN ST19 form for Certificate of Compliance.
