# Wicker Patio Furniture

CabanaCoast® offers to the original purchaser a 5-year Limited Warranty on the aluminum powder coat frame of our Wicker Patio Furniture if it fails structurally during normal residential usage within 5 years from the date of purchase. The wicker fibers featured in our Wicker Patio Furniture are warranted by the fiber manufacturer for 3 years from the date of purchase. Warranty covers fading and breakage. The Motion Pieces' mechanism is warranted for a period of 1 year from the date of purchase. Please refer to our care guide for wicker patio furniture care instructions.

## Cast Aluminum Patio Furniture and Extruded Aluminum Patio Furniture

CabanaCoast® offers to the original purchaser a 15-year Limited Warranty on the Cast Aluminum or Extruded Aluminum Patio Furniture if it fails structurally during normal residential usage within 15 years from the date of purchase. A 5-year Limited Warranty applies to the finish of Cast Aluminum & Extruded Aluminum Patio Furniture against peeling, cracking, or blistering for a period of 5 years from the date of purchase. The Motion Pieces' mechanism is warranted for a period of 1 year from the date of purchase. Please refer to our care guide for cast and extruded aluminum furniture care instructions.

## Sol Teak® Patio Furniture

CabanaCoast® Sol Teak® Patio Furniture is made from virgin MGP (Marine Grade Polymer) which is extruded under high pressure. The grain runs throughout the entire frame thickness and each joint is bolted together using stainless steel hardware. CabanaCoast® offers to the original purchaser a 3 year Limited Warranty on the frame if it fails structurally and also on the finish against cracking, peeling or fading during normal residential usage. # **Sling Patio Furniture**

Our sling patio furniture features durable cast aluminum frames and Sunbrella® or Batyline® sling fabric. Sling furniture provides comfort without the need for cushions making this collection very easy to care for. The sling fabric is also replaceable.

CabanaCoast® offers to the original purchaser a 15-year Limited Warranty on the Cast

Aluminum frame if it fails structurally during normal residential usage within 15 years from the date of purchase. A 5-year Limited Warranty applies to the finish of Cast Aluminum Patio Furniture against peeling, cracking, or blistering for a period of 5 years from the date of purchase. The Sling fabric and Motion Pieces' mechanism is warranted for a period of 1 year from the date of purchase. Please refer to our care guide for sling patio furniture care instructions.

#### Stainless Steel Patio Furniture and Stainless-Steel Furniture

CabanaCoast® offers a 5-year Limited Warranty on the Stainless-Steel Patio Furniture & Stainless-Steel Furniture if it fails structurally during normal residential usage within 5 years from the date of purchase. Please refer to our care guide for stainless steel furniture care instructions.

#### **Restaurant Patio Furniture**

CabanaCoast® offers a 3-year Limited Warranty on the Restaurant Patio Furniture when used for commercial applications. The warranty covers the Restaurant Patio Furniture paint finish, wicker fibers, and if the frame structure fails during normal usage while following proper care, maintenance, and storage procedures.

#### **Outdoor Fire Pits**

CabanaCoast® offers to the original purchaser a 15-year Limited Warranty on the Aluminum Fire Pits' table top and base if it fails structurally during normal residential usage within 15 years from the date of purchase. A 5-year Limited Warranty applies to the finish of the Fire Pits' table top and base against peeling, cracking, or blistering for a period of 5 years from the date of purchase. CabanaCoast® warranties all burner components for the Fire Pits when used under normal usage with proper maintenance for 1 year from the date of purchase. Regular maintenance must be exercised as set forth in the owner's manual. Please refer to our care guide and the product manual for outdoor fire pit care instructions.

Fabrics are warranted based on the warranty provided by the Fabric manufacturer to CabanaCoast®. Please refer to our care guide for patio furniture cushions and fabric care instructions.

#### **Patio Furniture Covers**

CabanaCoast® offers a 1-year Limited Warranty on the Patio Furniture Covers, covering any manufacturing defects for 1 year from the date of purchase. Please refer to our care guide for patio furniture covers care instructions.

#### **Commercial Patio Furniture**

When CabanaCoast® Patio Furniture is used for commercial applications, including any public area, common area, or individual units of a commercial property, during normal usage, while following proper care, maintenance and storage procedures, CabanaCoast® will cover:

- Wicker Patio Furniture: frame 5 years, wicker fibers 3 years
- Cast Aluminum and Extruded Aluminum Patio Furniture: frame 5 years, finish 3 years
- Sol Teak® Patio Furniture: 3 years frame and finish
- Sling Patio Furniture: frame 5 years, finish 3 years, sling 1 year
- Outdoor Fire Pit: frame 5 years, finish 3 years, burner components 1 year
- Umbrellas: frame, canopy, and umbrella base 1 year
- Outdoor Cushions: 1 year
- Stainless Steel Patio Furniture: frame 5 years
- Motion pieces' mechanisms are not covered.

#### **Salt Water Environments**

CabanaCoast® offers to the original purchaser a 1-year Limited Warranty on the finish of:

- Wicker fibers against fading or breakage
- Cast Aluminum & Extruded Aluminum Patio Furniture against fading, peeling, cracking, or blistering
- Outdoor Fire Pits against fading, peeling, cracking, or blistering
- Stainless Steel Furniture

CabanaCoast® offers to the original purchaser a 3-year Limited Warranty on the finish of SolTeak® Patio Furniture against cracking or fading during normal residential or commercial usage.

CabanaCoast® defines salt water environments as any location within 1 mile of an ocean environment or around salt water pools. Please see our Patio Furniture Care Guide for normal required salt water maintenance procedures.

#### CabanaCoast® Will Do:

CabanaCoast® will, at our discretion, repair or replace the frame without charge; parts and labor included. Replacement will be in the original color and style whenever possible; however, equal value replacement will be offered in the event of product or color discontinuance. Replacement will be for the damaged item only. During the first year after purchase, CabanaCoast® will pay all the freight costs to send the replacement to the dealer. This does not include installation charges. After the first year of purchase CabanaCoast® will not be liable for any freight costs.

#### Purchaser Must Do:

To obtain service, contact your dealer stating the problem, providing photograph and sales receipt or invoice. A Return Merchandise Authorization will be sent to the dealer giving instructions for returning items if necessary. No returns will be accepted by CabanaCoast® warehouse without prior written authorization from CabanaCoast® Customer Service Department. Item must be returned in proper packaging.

 Acts of nature (such as wind, freezing - including splitting and breakage from water accumulation in tubing)

- Vandalism, Fire, Abuse, or damage of any kind
- Animal damage

- Wicker breakage due to scratches or excessive friction, glass breakage, and rust on steel
- Failure to take reasonable care of the furniture including following proper care and maintenance

- Fading and wearing of hand-applied finishes as well as slight variations in color and texture of aluminum finishes and minor variations in wicker fibers
- Fading, staining and mildewing of fabrics and compression of cushion fillings/fiber

- Alterations and/or modifications
- Burn marks including those resulting from sunlight passing through glass filled with liquid which can at certain times act as a magnifying lens
- Damages due to improper assembly or handling
- Clearance, discounted "as is" and damaged items
