**YOUR RESPONSIBILITIES REGARDING RENTED EQUIPMENTS APPEARING ON YOUR INVOICE:**

- Complete your rental request with true and accurate information, as they are crucial in the choosing of your equipment, such as weight, height, age, and skier level.
- Your rented equipment has been chosen especially for you, in regards to the information given at the time of the rental, to fit your needs and personal characteristics. You must be the **ONLY** user of your equipment and must not let anyone else use it.
- Equipment must be used under normal conditions and for the usage it was designed for.
- For your own safety, do not alter or modify your equipment in any way whatsoever (duct tape, stickers, markers, engraving, etc.) nor change the adjustments that were made by our technician at the time of the rental.
  - If you feel the adjustments are not working out for you, come back to the store so we can adjust it to desired performances, do not attempt to change the adjustments yourself.
- You are entirely responsible for maintaining your equipment in good shape and storing it properly. Please keep it in a dry tempered area, away from any heat source.
- You must respect the deadline given to return your equipment: September 30<sup>th</sup> XXXX. In case of damaged equipment, you will be charged for repairs if repairs are possible.
  - In case of lost or unreturned equipment after September 30<sup>th</sup> XXXX, you will be charged for the full value of all products on your invoice (shown below), in addition to the rental fees you've already paid for.
  - You also have the possibility to purchase your equipment, if you do, **a credit will be granted equivalent to 50% of the rental fees**, to apply on that purchase.
  - In case of stolen equipment, we offer a small insurance fee that will covered the price of equipment by providing an official police report of the theft.

**OUR RESPONSIBILITIES**

2. We will proceed to the final adjustments when you pick up your rental, according to the guide lines' industry for the sports' equipment chosen.
