\_\_\_\_\_(initial) **TERMS**

- Mid Century Market will establish and set the pricing on all consigned items. We will always strive to secure the best possible price for your item based on manufacturer, quality, condition and marketability of the piece.
- Sales and promotions are at the discretion of Mid Century Market in order to keep inventory fresh and moving
- Items will be accepted for a 120 day consignment period starting from the day that the consignment agreement is completed.
- Consigned items will be reduced in price via a preset markdown schedule. There is a progressive **price reduction of 10% every 30 days**.
- All consignment items must be clean and in displayable condition
- Consignor understands that if consignor's piece requires restoration it may not be completed right away as Mid Century Market has many pieces in the restoration queue.
- All items consigned with Mid Century Market remain the property of the consignor. While all reasonable efforts will be made to keep consigned items clean and safe from damage; **Mid Century Market is not responsible for loss or damage to consigned articles** from fire, water, theft, damages or other casualty. Please ensure that all items are covered under your homeowner's policy or such other insurance as you deem appropriate.
- If consignor's piece requires restoration by Mid Century Market (and/or others) and consignor decides to remove a consigned piece from Mid Century Market's possession consignor may do so but only after compensating Mid Century Market for the costs of restoration.

\_\_\_\_\_(initial) **COMMISSION**

- I understand my share is 50% of the final selling price for items sold within the 120 day consignment period. Any restoration costs, shipping costs not paid for by the buyer, payment processing fees and moving costs will be deducted from the final selling price prior to calculating the 50% consignor payment.

\_\_\_\_\_(initial) **UNSOLD ITEMS**

- If you wish to retrieve your unsold items you must do so within 5 days after the end of the consignment period. Please mark your calendar as Mid Century Market does not call to notify of unsold items. Items left in the shop 5 days after the consignment period ends will be donated to a charitable organization or liquidated at the discretion of Mid Century Market. All liquidation proceeds become the property of Mid Century Market.
