

Flea Market Participant Contract

Friday, August 16, 2024 10am to 2pm

Saturday, August 17, 2024 10am to 5pm

Sunday, August 18, 2024 10 am to 5pm

Please make sure that you read the rules carefully. This helps us make an accurate accounting of your items. **We will not accept items** if they are not prepared properly.

1. Register as a Participant on CreativeEscape.com. I understand that there is a non-refundable \$25 participation fee. In exchange for participating in the Flea Market, I will receive a promotional coupon for my sold items (less 25% commission) which will expire February 1, 2025. I will pick up my coupon (restrictions apply) starting on September 10, 2024.
2. I have purchased my participant spot with the designated code I will be using. (Be sure to pick the initials you want if they are available.)
3. I understand that my registration is not complete until I turn in a **signed copy of this contract, in person only**, by July 31, 2024.
4. I understand that all items must be packaged securely. This is as much to keep people out, as to keep items in the package. Please use lots of clear packing tape (no staples), even on Ziplock type bags. Stamp sets, miscellaneous products (ink pads, etc.) should be placed in plastic bags and taped shut. Containers holding stamp sets must also be taped shut. Any items with blades must be heavily secured. Papers and stickers should be placed in groups in clear bags and taped shut. Single sheets of paper and stickers will not be accepted. Creative Escape will not accept items that are not packaged securely.
5. I understand that there will be 3 days of sales: VIP day on Friday, Regular Day on Saturday and the option of 50% off Sunday. I will attached a special label to my products (given to me by Creative Escape when I drop off my contract in person), if I want any unsold items to be part of the 50% off. 50% off items on Sunday will also be part of the value of my promotional coupon.
6. I understand that items to be sold are restricted to the categories listed below. All items are sold at the discretion of Creative Escape.

7. I understand that items can only be dropped off during the drop off window, August 11-14, 2024. I will bring my items in disposable bags or boxes and sorted by type. For example, all paper will be in a bag/box and all stamps in another. Creative Escape is not responsible for returning your containers. I will drop my items off in the designated area for that category. If I do not drop my items in the proper place, an additional 5% commission fee will be added.

Drop off times:

August 11 6pm to 8pm

August 13 10am to 8pm

August 14 10am to 8pm

8. I will make a list of items and prices; this list will be dropped off with my merchandise and will be kept by Creative Escape. Make an extra copy for yourself. This list may be as detailed as you would like.

This is a tool we use to help identify items who price tags have fallen off. I understand that items cannot be sold if price falls off. It is my responsibility to check the orphan box for anything that may be pulled off the floor and deemed as unsellable. Creative Escape is not responsible for missing/lost items.

9. The Flea Market is not intended for dealers, resellers, other small business owners, Etsy shop owners, crop event owners or any other craft related businesses. I understand that if I bring several new items that are identical, I may be classified as a dealer and therefore be ineligible to participate.
10. I understand that I have to pick up any leftover items by August 23, 2024 and there will be no donations. If I do not, it will jeopardize my ability to be a future flea market participant. Any leftover items will be disposed of on Saturday August 24, 2024.
11. I understand that all supplies must be marked with my participant code and price. I will follow the rules below:
 1. The last digit of all prices must end in .00 or .50
 2. Codes and prices must be computer printed or typed using upper case, block style letters only. Please use at least a 18 point font.
 3. No Items with Handwritten Codes or Prices will be Accepted.
 4. Price tags must be placed on top of all items in the **upper right hand side**.
 5. It may be necessary to cut a smaller tag for smaller items.
 6. Firmly attach all tags with clear packing tape (keep in mind this is like a rummage sale). Items with no label will not be sold.
 7. The only information on the tag should be your 2 letter code and price. Use a separate label for any other information, such as description of contents, you may want to include.
 8. I will pick up my unsold items by Friday, August 23, 2024. If I do not, it will jeopardize my ability to be a future flea market participant.
 9. Creative Escape is not liable for any missing/lost items.
 10. I will attach the 50% off label (given to me by Creative Escape) under the price label, prior to drop off if I am participating in that promotion.
