EXECUTIVE DIRECTOR'S REPORT



When Global Gifts started thirty (!) years ago, a postage stamp cost 24 cents and the average house price was \$61,000. The Iran-Contra Affair was one of the big news headlines. Students in Burma planned a huge prodemocracy protest. A dedicated group of volunteers formed Global Gifts and many are still involved today, decades later.

In preparation for our 30 year anniversary celebration, I thought back over my own career with Global Gifts. Wow, what a time it has been! I was introduced to the concept of fair trade while living in Northern Ireland in 1999. I was so impressed with fair trade that I chose it as the topic of my master's thesis. The mix of social mission with a business operation excited me then, and still does today. Doing

research about fair trade for my paper is what brought me to the doorstep of Global Gifts in the summer of 2000. I interviewed then-manager Julie Bontrager and began volunteering in the store. Soon an opportunity for part-time employment became available at Global Gifts and I became the "community liaison." This allowed me to enthusiastically share my new knowledge about fair trade – and having just completed my thesis on the topic, I'm sure some of the small groups that received my presentation got more than they had reckoned for! When the manager position became available in early 2001, I applied. The board was close to hiring another candidate but that person insisted that Global Gifts change its name to Ten Thousand Villages and become a "contract store". Instead, the board selected me to be the next manager and elected to continue on as Global Gifts, even though finances were a bit shaky and the future was uncertain at the time.

During my tenure with Global Gifts, we have continuously striven to increase the impact we have through fair trade. Opening new stores has been the biggest source of growth. In addition the Helping Hands Festival of years past, helping to edit and publish the children's book Think Fair Trade First!, developing our relationship with Imani Workshops in Kenya, and expanding our community presence through participation in events and speaking engagements have all been ways in which Global Gifts has grown sales and raised awareness about fair trade.

Our local efforts are connected to a much larger movement. During a recent Fair Trade Federation Conference, I heard from Narseen Sheikh from Local Women's Handicrafts in Nepal. Narseen is a young woman in her 20s and is providing incredible leadership to young women and girls by fighting for women's rights and against forced marriage, which is a common situation for young Nepalese girls. Narseen worked as a child laborer for many years and was separated from her home and family. She was held captive for so long and at such a young age that even today she is not sure how old she is. Through different connections, Narseen was fortunate to learn to read and receive an education. She learned to sew and make handicrafts to sell. And an older brother supported Narseen when she was defiant against an arranged marriage her parents demanded of her.

Narseen took these small but significant opportunities, these small supports, and through them was empowered to receive her own university degree and start Local Women's Handicrafts. She is dedicated to providing as many girls and women in Nepal the same chance and support that she received, that in turn made dramatic improvements to her own life story. As we just learned about Narseen this spring, we do not currently purchase from Local Women's Handicrafts; however, her story of trial, betterment, and determination to lend a hand to others plays itself out over and over again in the fair trade marketplace.

The work we do is critically important. We support businesses that empower the vulnerable and provide skills and opportunity where both education and hope are not easily obtained. Our work connects us to countless people through a trading relationship based on the ideal of dignity and opportunity for all. It has been such a pleasure working along the many active supporters of Global Gifts to grow fair trade across the globe over these past 17+ years. It's been an honor and benefit to me to serve with you. Though I am stepping away from my role I hold much excitement for the impact yet to come. Global Gifts has an excellent team in place and under the leadership of Alissa Head I know the good and important work of Global Gifts will continue with integrity. I look forward to the many years of progress yet to come.

When I began my new role as the Store Manager at Global Gifts Nora in September, I was eager to learn as much as I could about my position, volunteers, and new customers. The holiday season was approaching but a dedicated and talented team of staff and volunteers were ready to meet the challenge. Together, we tested new approaches to our product displays such as placing Phoenician Glass goblets and tea light holders in the window for any passerby to see (they are quite dazzling in the sun!) and strategically framing our checkout counter with holiday ornaments and woolens on either side. We also worked hard to capture contact information from our customers when they got a country club card – Nora led the stores in this effort with 44% of our receipts having customer names attached!

Compared to the 2016 holiday season, we saw a sales increase in ornaments, blankets, gloves, socks, soaps. However, we saw a decrease in typically high performing categories like jewelry, woolens, scarves, and food – contributing to a 4% decrease in sales for the year. To combat this trend, in 2018 we will be focusing on factors that are essential to Nora's growth: fostering our relationships with our loyal community and customers, increasing foot-traffic through exciting events and social media, and creating a store that is bright and shoppable to enhance the customer experience. So far in 2018, our traffic count is low but our conversion rate (the rate at which a "looker" becomes a "shopper") is the highest it's been since 2013! This means our volunteers are doing an amazing job giving their best "above and beyond" customer service and ensuring every visitor is finding the perfect gift.

Speaking of those fantastic volunteers, our team of 52 gave an impressive 4,295 calculated hours to Nora in 2017. A special thank you goes to Mona Stephens, Vicki Sholty, and Suzanne Murray for volunteering more than 200 hours! We also recognize the 13 volunteers who worked 100+ hours: Linda Bullard, Ann Carlson, Marcella Slabosky, Cindy Mast, Rick Peters, Anne Lennon (also holiday staff!), Elizabeth Blanchard, Joanne Dankert, Beverly Cox, Donna Marsh, Linda Showalter, Bev Hendricks, and Marsha McDaniel. All of our volunteers help Global Gifts in many ways: passionately educating newcomers about fair trade and our artisans, exciting customers with their favorite products and helpful suggestions, adapting to an ever-changing floor layout, liking and sharing our social media posts, and even repairing jewelry and pesky balsa wood cats. YOU are our biggest advocates and we appreciate every effort – no matter how small.

I also want to thank Kelly Trimble, Nora's previous store manager, for her guidance and leadership. On my first day, she was there to teach me everything she could: from her philosophy on the Nora customer's favorite products, being a role model in her customer service talents, to her ability to connect Global Gifts with the Indianapolis community and beyond. She may have left her role in September but she still ensured our store would be successful by working with us during the holidays while our Volunteer Coordinator was on maternity leave. We appreciate you, Kelly!

Finally, the work that we do at Global Gifts isn't easy but I am continually inspired by every person who gives their unique skills and perspectives to this organization. Every day, you better the lives of artisans and farmers across the globe, strangers who you may never meet. Cheers to 2018 and the work we will do together!

It's been a year of changes for Bloomington! We're used to change here. Being in a university town we always have new faces in the store, both customers and volunteers. They say change is good and, for the most part, they were good for our store in 2017. It was our best sales year since 2014!

Athena, a neighboring store, closed in January, and we were pleasantly surprised to see an abundance of new shoppers finding us. We hadn't realized just what strong competitors they were, and we saw sales growth! Strangely, when the Gather Shoppe, featuring local and Indiana made items, moved into their space in May, we didn't see any slow in our sales. Rather, we had friendly new neighbors with a synergy between our stores, and we continued to see sales growth!

We had significant changes with our campus relations. In 2017, Global Gifts Short North in Columbus showed an increase in sales every month of the year, including a 6% growth in December holiday sales! We are very proud of our accomplishments last year, such as getting a Bunyaad Rug Event under our belt and offering ecommerce sales, fulfilled from inventory in our store! We also extended our hours starting in July and continued them through the holidays, which helped us be more available to evening shoppers who were in the district for dining and nightlife. While later hours did not always equate to more sales in the evening, being open later increased awareness about our store and fair trade, and we saw more customers returning to purchase products at a later time.

Our volunteer support remained steady at around 40 active volunteers and interns at all times, with an overall growth from approximately 3800 volunteer hours in 2016 to 4000 volunteer hours in 2017! We continue to partner with The

Ohio State University, Columbus Alternative High School, Bishop Watterson High School, and The Graham School on volunteer internship programs.

We participated in many events in 2017! In addition to our regular offsite events like Comfest, The Ohio Fair Trade Expo, and Highland Presbyterian Church's Alternative Gift Fair, we added a holiday event at Powell United Methodist Church. We also participated in Ohio State University's Green Week and Time for Change Week fashion shows on campus.

In store, we joined in for Experience Columbus's Short North Know Your Neighborhood Event in September. Columbus Food Adventures continued to come every Saturday, bringing groups of up to 15 people to sample fair trade coffee and chocolate in the store and to learn about fair trade and the Global Gifts mission. Our Sugar Skull workshops in October were once again well attended. We had Engineers Without Borders OSU in the store for Cultural Story Time, and a Columbus College of Art and Design Fashion Class in the store for a talk about EcoFashion.

We partnered with the Girl Scout Convention, which brought 10,000 girl scouts from all over the US to Columbus in October, providing a Fair Trade Pin opportunity in the store in collaboration with the Girl Scout Convention planning committee.

We gained press coverage in 2018 from Fox28 TV's Cam About Town, This Week Newspapers, The Lantern, and the Craftin' Outlaws blog.

We saw a few staff changes in 2017, including hiring seasonal staff Jieqing Yang and Kris LoFrumento, who have stayed on in 2018 to help fill Samantha Lada's position. We have also brought on Heather Ziegler this year as a new part time staff person to help us fill extended hours shifts which started in March.

Although 2018 is off to a bumpy start with construction in the district, we are excited about new opportunities this year, including a partnership with Columbus Gives Back for volunteer groups who were a big help at our Bunyaad Rug Event in March, showing off our Gift Registry at the Short North Wedding Wander in April, the Day of the Dead Community Event with Latino Arts for Humanity in October, and having our store featured in Virtual Reality with immersive.is, a local virtual reality company.


