RECYCLERY PARTICIPANTS Release and Waiver of Liability

This Release and Waiver of Liability ("Release") is executed on ____ / ____ / _____, by _____ (Participant or Guardian of Participant) in favor of the RECYCLERY, a Washington non-profit entity organized and existing under the laws of the State of Washington, USA, its directors, officers, employees, volunteers and agents, and all persons and entities with interest in the real property within the jurisdiction of the RECYCLERY.

I, _____, (Participant or Parent/Guardian of Participant) execute this Release on behalf of myself, my marital community, and on behalf of any other individual with related interests. I and/or my child desire to participate in _____ (program) at the RECYCLERY. I understand that my participation may present risks, including but not limited to risks associated with mountain bike trail riding, mountain bike racing, physical activity, use of equipment, outdoor elements, risks presented by extreme weather conditions and outdoor activities.

I hereby freely, voluntarily, of my own will, in the absence of duress or extenuating circumstances, and after consultation with and approval by my spouse and/or any other individual with related interests, execute the following:

1. **Waiver and Release.** I, on behalf of myself, and on behalf of any other individual with related interests, agree to release, forever discharge and hold harmless the RECYCLERY from any claim that may exist for any bodily injury, personal injury, illness, death or property damage that may result from my / my child's participation as a RECYCLERY volunteer. This release shall be interpreted to be as broad in its extent and purpose as the law will allow, including release of any claims arising from negligence. I also understand that the RECYCLERY assumes no responsibility or obligation to provide financial or other assistance in the event of injury, illness, death or property damage.
2. **Insurance.** The RECYCLERY carries some health, medical or disability insurance coverage for volunteers. Volunteers are encouraged to carry additional coverage if they so desire.
3. **Medical Treatment.** I hereby release and forever discharge the RECYCLERY from any claim that may arise on account of any first-aid treatment or other medical services rendered in connection with my / my child's participation as a RECYCLERY volunteer.
4. **Indemnification / Assumption of Risk.** I understand that my / my child's participation in this RECYCLERY program may include activities that may present hazards, including, but not limited to risks associated with physical activity, use of equipment, outdoor elements, risks presented by extreme weather conditions and outdoor activities. I hereby assume the risk of all injury, harm, illness, death and property damage that may result from my / my child's participation in this RECYCLERY program. I agree to release and indemnify the RECYCLERY with respect to any liability for injury, harm, illness, death or property damage that may result from my / my child's participation in this RECYCLERY program. I intend this indemnification / assumption of risk to be as broad in its extent and purpose as the law will allow, including assumption of risk and indemnification with respect to any claim that may arise from negligence.
5. I have read the entire Release, and understand all of the provisions. I understand that I may consult with independent legal counsel before signing this agreement if I have any questions or concerns. I express my agreement with the foregoing provisions by my signature below.
