



Youth Programming General Waiver

Please read this document carefully. By signing below, the Youth participant (defined below) and their Guardian acknowledge and agree to the terms of this Youth Programming General Waiver.

BY SIGNING BELOW, I CONFIRM I HAVE REVIEWED AND AGREE TO BE BOUND BY THE YOUTH PROGRAMMING GENERAL POLICY (THE “**GENERAL POLICY**”).

IN CONSIDERATION of being allowed to participate in Youth Programming at Woodburn Games (“**Woodburn**”) located in Cincinnati, OH, the receipt of which is hereby acknowledged, _____ (“**Youth Participant**”), and as their Guardian, I, _____ (“**Guardian**”, together with Youth Participant, “**We**”), hereby agree to the following:

1. Details of the Activity

The Youth Participant will be participating in the following activity (the “**Activity**”):

2. Consideration

For the Youth Participant being permitted to participate in the Activity, we release and discharge Woodburn, its owners, directors, officers, employees, agents, assignees, legal representatives, and successors from all actions, causes of action, debts, accounts, bonds, contracts, claims and demands for or by reason of an injury to person or property, including injury resulting in death of the Youth Participant which has been or maybe sustained as a consequence of the Youth Participant's participation in the abovementioned Activity and notwithstanding that such damage, loss, or injury may have been caused solely or partly by the negligence of Woodburn.

We acknowledge and understand that this Waiver herein is given in order to extinguish certain obligations owed to the Youth Participant by Woodburn intending to bind the Youth Participant's spouse, heirs, executors, administrators, parents, Guardian(s), legal representatives, and assignees.

We agree that the Youth Participant will not participate in the Activity if we have not read, do not understand, or do not agree with this Waiver or the General Policy.

3. Fitness to Participate

We acknowledge that the Youth Participant does not have any physical impairment, limitations, medical conditions, or physical/mental disabilities that would limit or prevent the Youth Participant from participating in the Activity without substantial accommodations.

4. Pick Up Policy

Guardian acknowledges and agrees to be bound by the Pick Up Policy detailed in Section 7 of the General Policy.

5. Community Guidelines

We understand that we are expected to follow all posted community guidelines. Community guidelines are posted at Woodburn's location and reviewed with all Youth Participants in age-appropriate language at the start of the Activity.

Consequences for violating the community guidelines will be handled at Woodburn's sole discretion based on the severity of the violation and in consideration of the Guidelines detailed in Section 9 of the General Policy.

6. Discipline Guidelines

Whereas “**Store Suspension**” is defined as a six (6) month period in which the Youth Participant is not able to participate in Activities organized by Woodburn, the Youth Participant will be given the following consequences for minor violations of the community guidelines:

- 1st offense: conversation with Youth Participant
- 2nd offense (within 6 months): conversation with Youth Participant and Guardian.
- 3rd offense (within 6 months of 1st offense): Store Suspension

Major violations of community guidelines will result in an immediate Store Suspension. After the second major violation of community guidelines, the Youth Participant will no longer be welcome at events organized by Woodburn.

7. Photo Release

We grant permission to Woodburn to photograph or videotape the Youth Participant during Youth Programming, and to use these images, videos, or audio recordings in Woodburn’s promotional materials, social media, website, and other lawful publications.

We understand and agree that:

- (1) No compensation will be due to the Guardian or Youth Participant for such use of likeness;
- (2) All images and recordings taken at Youth Programming are the property of Woodburn. Further, Woodburn may edit, publish, or distribute such images or recordings and we waive any right to inspect or approve the same;
- (3) Woodburn will not disclose the full name or personal identifying information of the Youth Participant without the Guardian’s written consent; and
- (4) We release and hold Woodburn harmless from any claims arising out of the use of these images or recordings, including any claims of libel, privacy, or copyright.

8. Full and Final Settlement

We acknowledge that:



- (1) Woodburn has given the Youth Participant and Guardian enough time to carefully review and read this Waiver;
- (2) We have been encouraged to seek legal advice prior signing this Waiver;
- (3) We fully understand the risks and claims that we are waiving to participate the Activity;
- (4) We are voluntarily signing this Waiver;
- (5) We are forever prevented from any cause of action, suing, or otherwise claiming against Woodburn for any property loss or personal injury that the Youth Participant may be exposed to while participating in or preparing for the Activity.

9. Acknowledgement of Understanding

This Waiver herein is construed in and governed by the law of the State of Ohio. If any part of this agreement is found to be unenforceable or invalid under Ohio law, the **remainder of the agreement shall remain in full force and effect**. This document constitutes the entire agreement and release between the parties regarding liability and media consent, and it supersedes any prior representations or agreements regarding these matters.
