For organic stains such as sap, berries, or leaves and heavy oil stains, spray on undiluted and after a brief dwell time agitate with a scrub brush and rinse with a power wash.

For lighter jobs, **SIDEWALK CLEANER** can be prediluted with water and applied to the surface or it can be used with a power washer as the detergent. After cleaning, rinse all surfaces adequately as to not leave any residue.
